Entry Fees: Member \$15, Non-Member \$30 • Up to 2 original pieces allowed; "Artwork must not exceed 40" on any side, height or width," this includes the frame.

## EXHIBITION AWARDS

Awards will be given in accordance with GNAL policy on minimum number of entries required for each category.

## SUBMISSION RULES & ELIGIBILITY

Eligible to all Emerging artists. (definition at [www.gnal.org/about/policies](http://www.gnal.org/about/policies))

- Members may exhibit two pieces with \$15 entry fee.
- Non-members may exhibit two pieces with a \$30 entry fee.
- No previously exhibited work from any GNAL exhibits.
- You may opt to become a member at [gnal.org](http://gnal.org) or at drop-off.
- All artists must submit a signed Release and Waiver of Liability.
- Entries may be for sale or not for sale. NO POR accepted.
- In the event of a question regarding Emerging Artist status, the receiving team will have the sole right and responsibility in accordance with GNAL policy and procedures to determine an artist's status. Any work may be rejected for content or presentation if determined by the receiving team to be unsuitable for exhibition in the GNAL Gallery.
- All entries must be delivered to GNAL Gallery following the guidelines stated in this prospectus.
- GNAL does not assume responsibility for any work.
- GNAL does not insure your work.

## PLAGIARISM

- No copies of published art, photos, no clip art, no derivation from other artists' photographs, books, videos or artwork will be accepted at any of our shows or events. This includes images from the internet, even those that are "royalty free."
- At any time, and at the discretion of GNAL, if work is deemed to be copied from another artist's work or images, it will be removed from display immediately, and any prize awarded will be null and void. *The artist will also be banned from any show at or sponsored by GNAL for ONE FULL YEAR.*

## LIMITS

- Artwork must NOT exceed 40" on any side, height and width, this includes the frame.
- Utilitarian items such as furniture or vessels will NOT be accepted.
- ALL entries must remain for duration of the show. If artwork does not remain for duration, any prize awarded will be forfeited and ARTIST will be prohibited from ALL GNAL exhibitions for ONE FULL YEAR; NO EXCEPTIONS.

## SCULPTURE

- Artwork must NOT exceed 40" in any direction, height and width, this includes the base.
- ALL two-dimensional work must be properly framed and wired with braided wire ONLY. String, other types of wire, sawtooth hangers, etc. will not be accepted. All sculpture must have its own base. No three-dimensional piece may be attached to the wall or floor for support; must be freestanding with base, as well as being portable.
- Size and weight of work should be such to be moved easily and safely by one person. Weight of any wall hangings will be a consideration.
- Utilitarian items such as furniture or vessels will NOT be accepted.

## PHOTOGRAPHY

- Original photographic media accepted, traditional and digital.

## SALES

- 20% commission will be charged on all work sold by members during the show.
- 30% commission will be charged on all work sold by non-members during the show.
- Buyer's check must be made out to the artist. The artist assumes responsibility for payment of proper commission due to GNAL within 10 days of the sale. GNAL will accept cash or check.

## IMPORTANT

- **A Storage Fee of \$10 per day will be charged for storage of any works not picked up at designated time, unless prior arrangements are made with GNAL.**
- **Any art work left after 6 pm on the Closing Reception day, will be kept under lock and key for 30 days or until picked up by the artist. It is the artist's responsibility to arrange pick up, and to pay the \$10/day Storage Fees. (GNAL will accept cash or check). Although, GNAL will make every reasonable attempt to contact the artist, after 30 days the artwork will become GNAL's property and any cash awards will be forfeited.**
